In compliance of the Bangladesh Securities & Exchange Commission Gazette notification No. SEC/SRMID/2000-985/2248/Pro-02/01 dated 19/12/2000 the Board of Directors of HeidelbergCement Bangladesh Limited in its meeting held on 27 April 2022 at 1445 hours has taken following decisions:

**1) Approval of Financial Statements**

The audited Financial Statements together with Draft Director's Report thereof for the year ended 31 December 2021 has been approved for presenting to the auditors. The Company reported a net profit of Tk. 475.28 million during the year 2021 as against net loss of Tk. (4.92) million during the year 2020. Thus the Earnings Per Share (EPS) comes to Tk. 8.41 during 2021 as against Tk. -0.09 in 2020.

**2) Dividend Recommended:**

The Board of Directors recommends cash dividend of Tk. 2.6/- (Taka Two and Sixty Paise only) per share of Tk. 10/- each for the year ended 31 December 2021 out of funds available for appropriation.
