In compliance of the Bangladesh Securities & Exchange Commission Gazette Notification No. বিএসইসি/সিএমআরআরসিডি/২০২১-৩৯৬/৫২/প্রশাসন/১৪০ dated 30 January 2023 the Board of Directors of Heidelberg Materials Bangladesh PLC. in its meeting held on 24 April 2025 at 2.45 pm and has taken following decisions:

## 1) Approval of Financial Statements

The Audited Financial Statements together with Draft Director's Report thereof for the year ended 31 December 2024 have been approved. The Company reported a net profit of Tk. 461.79 million during the year 2024 as against of Tk. 459.41 million during the year 2023. Thus, the Earnings Per Share (EPS) comes to Tk. 8.17 during 2024 as against Tk. 8.13 in 2023.

### 2) Dividend Recommended:

The Board of Directors recommends 25% cash dividend (two taka & fifty paisa only per share of tk. 10/- each) for the year ended 31 December 2024 out of funds available for appropriation.
